

ORDINANCE NO. 989

AN ORDINANCE TO FIX THE SALARIES, WAGES AND COMPENSATION OF CERTAIN PUBLIC OFFICIALS, OFFICERS AND EMPLOYEES OF THE BOROUGH OF DEMAREST, COUNTY OF BERGEN AND STATE OF NEW JERSEY FOR 2011.

BE IT ORDAINED by the Mayor and Council of the Borough of Demarest as follows:

SECTION 1. That the annual salaries of the following officers and employees of the Borough of Demarest shall be paid in bi-weekly installments and fixed in the amounts set opposite their respective titles.

B. That the following fringe benefits shall be granted to the aforementioned employees:

1. Hospitalization for full family coverage as required.
2. All full time employees shall be entitled to receive vacation time and legal holidays as set forth in "Employee Policies".
3. All full time employees, hired prior to January 1, 1995, will be paid longevity at the rate of one (1%) percent for every three (3) years of service, from the commencement date of employment for those hired after said 1971 inception date.
4. All full time employees hired after December 31, 1994 shall not be eligible to receive longevity pay.

5. All full time employees shall be entitled to participate in the Delta Dental Plan Fund for dental coverage on an employee only basis.

SECTION 2. That the annual salaries of the following public officials of the Borough of Demarest shall be paid quarter-annually and fixed in the amounts set opposite their respective titles:

SECTION 3. That the annual salaries of the following officers and employees of the Borough of Demarest shall be paid in bi-weekly installments and fixed in the amounts set opposite their respective titles:

B. That the following fringe benefits shall be granted to the aforementioned employees.

1. Hospitalization for full family coverage as required.
2. The Acting Superintendent, Assistant Superintendent and Foreman shall be entitled to receive vacation time and legal holidays as set forth in "Employee Policies".
3. The Acting Superintendent will be paid longevity at the rate of one (1%) per cent for every three (3) years of service as of January 7, 1991, the commencement of employment.
4. The incumbent Assistant Superintendent will be paid longevity at the rate of one (1%) percent for every three (3) years of service as of May 14, 1973, the commencement date of employment.
5. The incumbent Foreman will be paid longevity at the rate of one (1%) percent for every three (3) years of service as of January 1, 1991, the commencement date of employment.

6. The Acting Superintendent, Assistant Superintendent and Foreman shall be entitled to participate in the Delta Dental Plan for dental coverage on an employee only basis.

SECTION 4. That the annual salaries of the following officers and employees of the Borough of Demarest shall be paid in bi-weekly installments and fixed in the amounts set opposite their respective titles.

SECTION 7. The compensation of the Sewer Inspector for each sewer inspection shall be \$20.00 which will cover two (2) inspections for each sewer connection required to a dwelling and will be paid monthly upon presentation of a duly executed voucher. Slab inspections to be paid at the rate of \$10.00 each.

SECTION 8 The compensation of the Construction Official for each resale certificate of occupancy inspection shall be \$35 and will be paid monthly upon presentation of a duly executed voucher.

SECTION 9. The following annual contractual/retainer fees shall be paid quarter-annually for attendance at regular and executive meetings of the respective Borough boards or municipal court sessions:

A. Planning Board Attorney - \$250 per meeting with maximum	\$3,000.00
Board of Adjustment Attorney - \$250 meeting with maximum	3,000.00
Borough Prosecutor	6,752.00
Borough Engineer	2,200.00

B. In addition thereto, the foregoing shall receive such other compensation as they may legally be entitled to receive for services rendered to the Borough upon presentation of bills properly sworn to as required by law.

SECTION 10. The following annual contractual/retainer fees shall be paid (a) monthly or (b) quarter-annually for attendance at regular and executive meetings of the Mayor and Council:

B. In addition thereto, the foregoing shall receive such other compensation as they may legally be entitled to receive for services rendered to the Borough upon presentation of bills properly sworn to as required by law.

SECTION 11. There shall be paid to the Borough Auditor an annual fee of \$32,200 for regular auditing services as rendered for the Borough including: Preparation of the Annual Debt Statement, Preparation of the Annual Financial Statement, Annual Budget and Annual Statutory Audit and in addition thereto such other compensation as he may be legally entitled to for auditing services other than the ordinary work upon presentation of bills properly sworn to as required by law.

SECTION 12. The annual Salary of the following officers of the Police Department of the Borough of Demarest shall be paid in bi-weekly installments and fixed in the amount set opposite their respective titles:

- B. That the fringe benefits granted to the aforesaid Chief of Police and Deputy Police Chief shall be those set forth in Section 1B of this Ordinance, except that longevity shall be paid as of the commencement date of employment.

SECTION 13. That the hourly rate of pay shall be as follows:

- B. All Crossing Guards, with the exception of those on a substitute basis, shall be paid for three (3) legal holidays: Good Friday, Thanksgiving and Christmas, one (1) snow day for each storm, to a maximum of four (4) snow days and vacation time as set forth in "Employee Policies".

SECTION 14. The aforementioned officers, appointments, positions, employment and policies are hereby created, confirmed and ratified. All other employees not specifically mentioned herein shall receive such hourly-yearly wages as the Mayor and Council deem fair and reasonable for services rendered.

SECTION 15. This ordinance shall repeal all ordinances or parts thereof, inconsistent herewith, shall take effect after public hearing and passage as required by law and shall be retroactive to January 1, 2011.
